1. Introduction

TabTrade (Mauritius) Ltd (“TabTrade”, “we”, “our”, “us”) may employ a range of technologies, including Cookies and similar tools, on our websites and mobile applications.

This policy describes what Cookies are and how we use Cookies and Other Technologies to provide you with a reliable and tailored experience when you browse or trade.

This policy also explains how you can manage your Cookie preferences while browsing our website and applications.

TabTrade is committed to managing your privacy and personal information responsibly. We respect your preferences and handle all information collected through Cookies with care.

2. Definitions

In this document, the following terms shall have the meanings set forth below, unless the context requires otherwise or unless otherwise specified:

“Cookie” means a small text file that a website requests to store on your device (such as a computer, smartphone or tablet) when you visit the site.

Cookies help the site remember details, including but not limited to:

- a. your language or region preferences;
- b. whether you’re logged in; and
- c. information that lets us analyse how the site is used.

Cookies don’t contain viruses, and they can’t read the files on your device. Once accepted, the file is placed on your device and helps analyse web traffic or lets us know when you visit our site.

Cookies enable us to provide you with a better website by identifying which pages are useful to you and tailoring our services to your preferences. To facilitate this, they store and recall information about your activity and device.

We only use Cookies to ensure our website functions correctly, to improve our analytics so that we can deliver a better client experience, and to provide marketing content that is relevant to you.

“Other Technologies” means technologies similar to Cookies that we may use within our apps and websites that allow us to track, report and analyse how our services are used, and to help keep them secure. These may be stored on the device you use to access our website or apps, similar to Cookies.

For ease of reference, we may use the term “Cookies” in this policy to include both Cookies and Other Technologies used to store data, collect information, or identify you.

3. How We Use Cookies

We use Cookies and Other Technologies to provide you and other users with access to our products and services through our websites and apps. We may also use third party services that use Cookies.

The Cookies used by our websites and apps do not store or access personal data

such as passwords or other information stored on your device.

The Cookies we use allow us to:

- a. understand how you use our websites and apps;
- b. check whether you are logged in to our websites or apps;
- c. track usage statistics;
- d. see how you arrived at our websites or apps;
- e. collect device information, including your location and web browser;
- f. display content that we believe is relevant to you; and
- g. save preferences or settings that can be used to personalize your experience on our websites or apps.

4. Types of Cookies

The specific Cookies used on our websites and apps may change from time to time as we update our systems, with some of the commonly used types outlined below.

Essential Cookies

These Cookies are required for the core operation of a site. They enable basic functions such as page navigation, secure login, and maintaining your session. Without them, the website would not work properly.

Functional Cookies

These Cookies remember choices you make - such as language, region, or display settings - and store personalized preferences. They improve usability by

ensuring the site behaves consistently each time you visit.

Performance / Analytics Cookies

These Cookies collect aggregated data about how visitors interact with the site (e.g., pages viewed, time spent, error reports). The information helps us understand usage patterns and optimize speed and reliability, but it does not identify individual users.

Marketing Cookies

These Cookies help us understand your interests. This enables the delivery of tailored marketing or advertising content. They may come from third-party ad networks.

Social Media / Interaction Cookies

These Cookies facilitate sharing content via social platforms (Facebook, Twitter, LinkedIn, etc.). They may also allow you to log in with a social-media account and record interactions such as likes or comments.

5. Managing Your Cookie Preferences

You can manage your preferences for Cookies through your internet browser settings. Each browser may have a different process to adjust these settings, with some common examples shown below.

Brave

1. Open the main menu by clicking the three-line "hamburger" menu

- icon in the upper-right corner of the browser
2. Choose Settings from the list that appears
3. Click Shields in the left-hand navigation column. Select the desired level of Cookie control from the Block Cookies section
4. You can further customize your preferences by selecting Privacy and Security and then Site and Shields Settings

Google Chrome

1. Click the three vertical dots menu icon in the upper-right corner of the browser
2. From the dropdown, pick Settings
3. On the left sidebar, select Privacy and security
4. Within that area, click Third-party Cookies, then select the desired level of Cookie control
5. To control site-specific options, under Privacy and security select the Site settings option

Mozilla Firefox

1. Press the three-line “hamburger” menu icon in the upper-right corner of the browser
2. Choose Settings from the list
3. In the left-hand navigation pane, click Privacy & Security
4. Under Browser Privacy, select the desired level of Cookie control
5. To control site-specific options, under Cookies and Site Data, select Manage Exceptions

Microsoft Edge

1. Click the three horizontal dots menu icon in the upper-right corner of the browser
2. Near the bottom of the menu, select Settings
3. If shown, select Manage Cookies; alternatively, in the left-hand panel, choose Privacy, search, and services and then Cookies
4. Select the desired level of Cookie control

Opera

1. Click the Opera logo icon in the upper-left corner of the browser
2. From the dropdown, select Settings
3. Select Privacy & security
4. Within that area, click Third-party Cookies, then select the desired level of cookie control
5. To control site-specific options, click Site Settings then Third-party Cookies

Safari

1. Click Safari in the upper-left corner of the browser
2. Choose Preferences... from the dropdown
3. Go to the Privacy tab
4. Select the desired level of Cookie control
